LCPS Fiscal Notes	<p>This is the 3rd year of the three-year CSI program. Note that this application is labeled “2020-21”, but the resources to be expended will be for the 2021-22 school year.</p> <p>This funding previously (in 2019-20) has funded intervention roles, additional curriculum purchases, and assessment platforms.</p> <p>In 2020-21, we’re on track to have possible rollover given that intervention roles hadn’t been staffed with COVID occurring, but could supplement further during spring 2021. If not,</p> <p>For 2021-22, we must submit our application by 1/20. Final decisions regarding resources can be adjusted later in our planning process, but the general scope must be defined in the application (see prompts below, particularly Prompt 3).</p>
