Eligibility for admission to the CSU is determined by three factors: (1) Specific high school courses, (2) Grades in specified courses and test scores, and (3) Graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 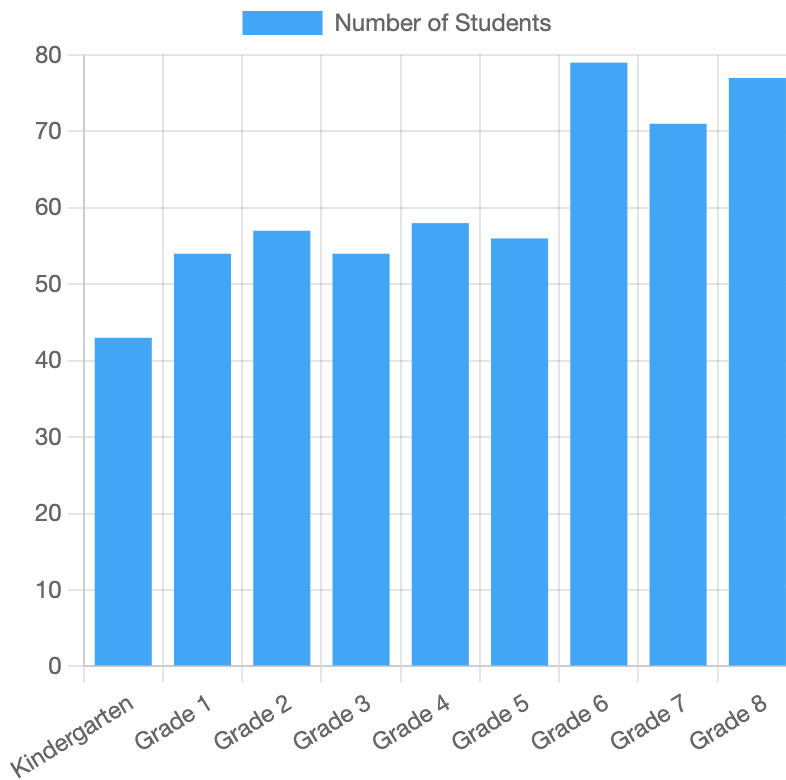
Lighthouse Community Public Schools exists to address the problem of persistent educational inequity that threatens our collective future.

Families have the opportunity for formal leadership through participation in the LEA's Parent Advisory Committess (PACs), which provide important input around the school's goals/priorities and the alignment of actions and funding towards those goals. In addition, there are robust opportunities for families to be involved in partnering around their student's learning and progress, including Student-Led Conferences (2-3x/year meetings between student, family, and advisor to discuss progress and set goals), Expos of student learning, and Passages (a tradition that confirms students' readiness to move forwards in all realms of achievement at selected grade levels). Families of our TK-5th grade students have also been participating in our Lit for Literacy program helping families to better understand their students literacy data and how to be partners with our schools to enable their students to become proficient readers.

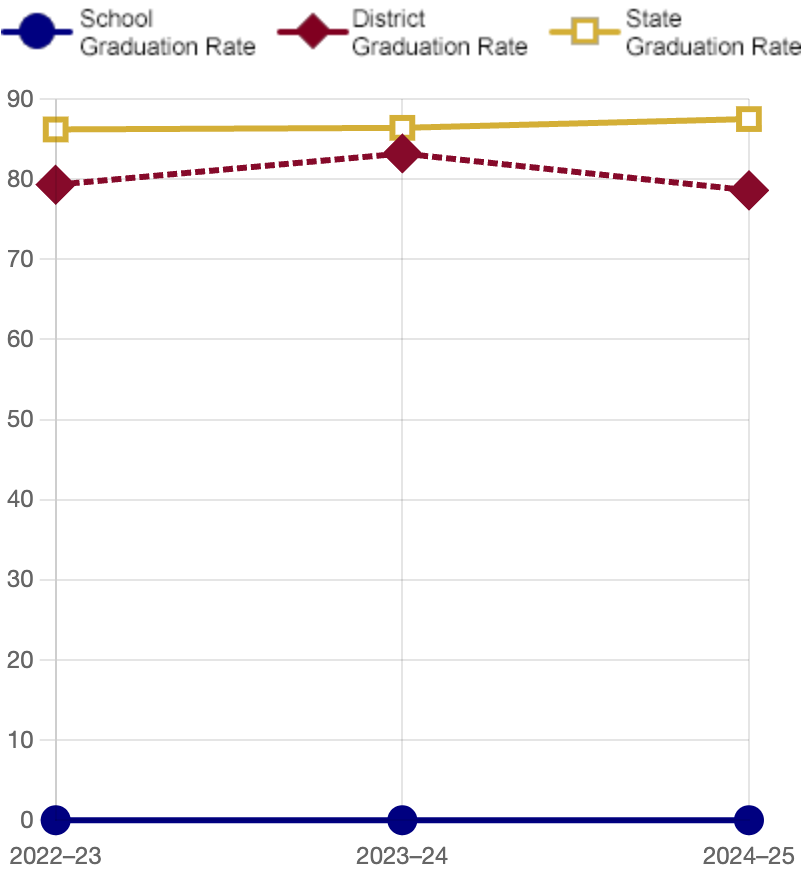
Graduation Rate and Dropout Rate (Four-Year Cohort Rate)

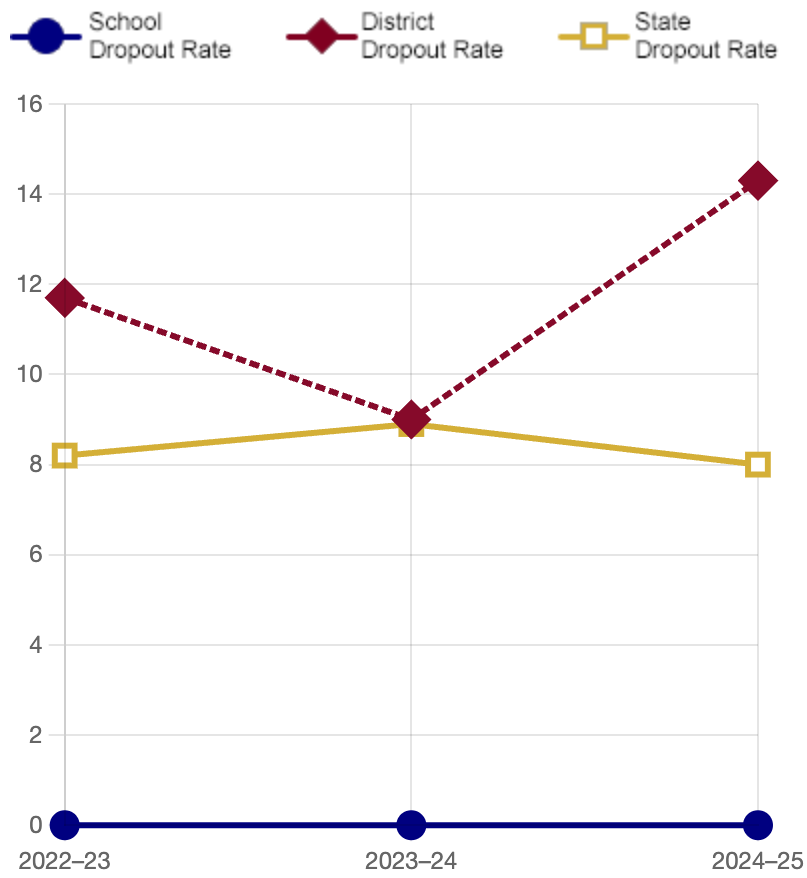

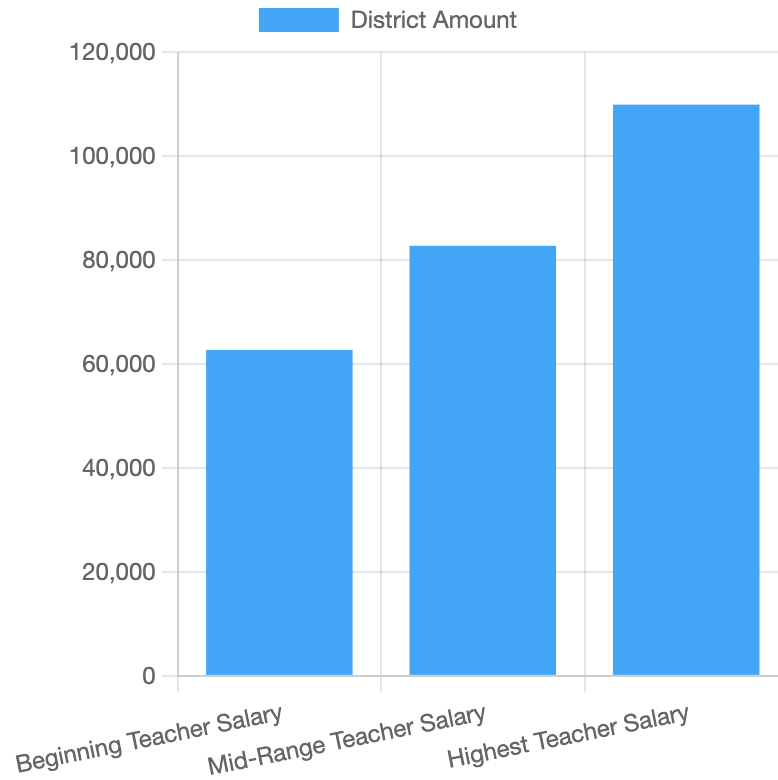
Types of Services Funded (Fiscal Year 2024–25)
